### **Introduction**

Emergent Seed LLC ("**ES**" or "**We**") respects your privacy and is committed to trying to protect it through our compliance with this policy.

This policy describes many of the types of information we may collect from you or that you may provide when you visit the website emergent-seed.org (our "**Website**") and/or using the Application and any attachments, as well as our practices for collecting, using, maintaining, or disclosing that information.

This policy applies to information we collect:

- On this Website, including through the Application there
- In email, text, and other electronic messages between you and this Website.
- When you interact with applications on third-party websites and services, any promotional or marketing, and if those applications or promotions or marketing, include links to this policy.

It does not apply to information collected by:

- Us offline or through any other means, including on any other website operated by ES, any owner(s) of ES, or any third party; or
- Any third party, including through any application or content (including promotions or marketing) that may link to or be accessible from or on the Website.

Please read this policy carefully to understand our policies and practices regarding your information and how we will treat it. If you do not agree with our policies and practices, your choice is not to use our Website or Application. By accessing or using this Website or Application, you agree to this privacy policy. This policy may change from time to time. Your continued use of this Website or Application after we make changes is deemed to be acceptance of those changes, so please check the policy periodically for updates.

### **Children Under the Age of 16**

Our Website is not intended for children under 16 years of age. No one under age 16 may provide any personal information to or on the Website. We do not knowingly collect personal information from children under 16. If you are under 16, do not use or provide any information on this Website or through any of its features, register on the Website, make any purchases through the Website, use any of the interactive or public comment features of this Website, or provide any information about yourself to us, including your name, address, telephone number, email address, or any screen name or user name you may use.

### **Information We Collect About You and How We Collect It**

We collect several types of information from and about users of our Website and Application, including information:

- By which you may be personally identified, including but not limited to name, postal address, e-mail address, telephone number, driver's license ID or other photo ID information, or any other identifier by which you may be contacted online or offline ("**personal information**");

- Various content which you provide, as described on the Website and Application, including but not limited to a video, underlying content, associated text, score, description, etc. (any and all “Material”).
- About you but individually does not identify you; and/or
- About your internet connection, the equipment you use to access our Website, and usage details.

We collect this information in different ways such as:

- Directly from you when you provide it to us.
- Automatically as you navigate through the site. Information collected automatically may include but is not limited to usage details, IP addresses, and information collected through cookies, web beacons, and other tracking technologies.

#### *Information You Provide to Us*

The information we collect on or through our Website and/or Application may include:

- Information that you provide by filling in forms on our Website or Application. This includes but is not limited to information provided at the time of submitting Applications for any reason, for example, for grants, internet or other “broadcast”, webinars, virtual or in-person events or purchasing or donating to have access to view videos or any other Material.
- Records and copies of your correspondence (including email addresses), if you contact us.
- Details of transactions you carry out through our Website and of the fulfillment of your actions or orders. You may be required to provide various types of financial information for various purposes, as further explained on the Website and/or Application, including before placing an order through our Website.

#### *Information We Collect Through Automatic Data Collection Technologies*

As you navigate through and interact with our Website, we may use automatic data collection technologies to collect certain information about your equipment, browsing actions, and patterns, including:

- Details of your visits to our Website, including traffic data, location data, logs, and other communication data and the resources that you access and use on the Website.
- Information about your computer and internet connection, including your IP address, operating system, and browser type.

The technologies we use for this automatic data collection may include cookies, flash cookies, and web beacons.

#### **How We Use Your Information**

We use information that we collect about you or that you provide to us, including any personal information and/or Material:

- To present our Website and its contents to you.
- To allow you to fill out and submit an Application

- To allow ES to evaluate applicants and/or Material for potential grants, internet or other “broadcast”, webinars, virtual or in-person events, and use all such via the License Agreement, linked to the Application
- To provide you with information, products, or services that you request from us.
- To fulfill any other purpose for which you provide it.
- To carry out our obligations and enforce our rights arising from any contracts entered into between you and us, including the Licensing Agreement and/or for billing and collection.
- To notify you about changes to our Website or any products or services we offer or provide through it.
- In any other way we may describe when you provide the information.
- For any other purpose required by ES to fulfill its stated goals, and/or obligations .
